### 2026 BOARD MEETING & NEW RATES

DAVID HILYER, CEO

On August 14, 2025, the Local Government Health Insurance Board met and approved a 4.75% premium increase for active employees, non-Medicare retirees, and Medicare retirees for calendar year 2026.

PricewaterhouseCoopers (PwC), a major healthcare consulting firm, projected an 8.5% medical healthcare cost trend for 2026. In 17 of the last 20 years, the LGHIB has been able to keep its rate increase below the PwC trend. We also continue to hear from local government entities, who are outside of our plan, about double digit rate increases. We are proud that our average rate increase throughout our 33 year history is 4.26%.

I hope you are making plans to attend our Benefit Administrators' conferences in October. We look forward to seeing, talking to and hearing from you. Thank you for the privilege to serve your unit and employees!

#### OPEN ENROLLMENT IS RIGHT AROUND THE CORNER

Open enrollment is coming in the month of November! If your unit or your members need to make changes, Open enrollment is the time to submit them to Local Gov. Changes made during open enrollment will be effective January 1, 2026.

As a reminder, below are changes that can be made during open enrollment.

## <u>During open enrollment, eligible members can:</u>

- Enroll in health and voluntary coverages
- Cancel health\* and voluntary coverages
- Add dependent and/or family coverage
- Drop dependent and/or family coverage

### **During open enrollment, units can:**

- Change their effective date of insurance for new hires
- Add or drop retiree coverage
- Add or drop coverage for elected officials
- Add or drop BCBS dental coverage

#### LET'S GET PHYSICAL WITH THE WOMEN'S PELVIC HEALTH PROGRAM

The Women's Pelvic Health Program is more than exercise therapy. Hinge Health combines gentle exercises with 1-on-1 support from an expert clinical care team, including a personal pelvic floor physical therapist. The Women's Pelvic Health Program could help with issues such as:

- Pregnancy and postpartum: prepare for and recover from childbirth. Prevent back, hip, and pelvic pain. Rebuild your abs.
- **Bladder control**: reduce urgent trips to the bathroom along with that "always gotta go" feeling that can result in leaking urine.
- Pelvic muscle relaxation and control: retrain your pelvic floor to reduce tension, relieve pain, and increase flexibility.
- Pelvic muscle strengthening: build your core muscles. Prevent leaks when you laugh, sneeze, or cough.

The pelvic floor therapy program with Hinge Health is a free benefit available for all subscribers, spouses, and dependents aged 18+.

#### LET'S TALK ABOUT: RETIREE COVERAGE

Local Gov Health & Wellness takes pride in providing health care benefits to serve the needs of our subscribers and their dependents throughout their life, from the first day of employment through the golden years of retirement.

### A few things to know about offering retiree coverage:

- Coverage is only available for subscribers who retire after the retiree coverage becomes effective.
  - No previous retirees could enroll in the coverage; only those who retire after the unit elects coverage will be eligible.
- Each unit determines how much it will charge the retiree for the health care benefits. We will send the bill to your unit, and you decide how much the retiree will pay.
  - The unit can cancel the retiree policy at any time for non-payment
- Retirees have the option to either enroll in the retiree coverage or find their own coverage, whichever works best for their health care needs.
  - If they don't enroll upon retirement or if they enroll and later terminate their retiree coverage, they can't return to the plan at a later date unless they become eligible again as an active employee.

# **Eligibility:**

To be eligible for retiree coverage, the participant must have at least 10 years of coverage in our plan, and:

- At least 25 years of service with a participating unit or other service as approved by the LGHIB, regardless of age; or
- Is at least 60 years old; or
- Is determined to be disabled by the Social Security Administration.

#### When to enroll:

 Units are able to make the change to offer retiree coverage during Open Enrollment in November for a January 1 effective date.

#### **How to enroll:**

 Complete the Unit Change form (LG11) and send it to enrollments@lghip.org during
 Open Enrollment, which runs from November 1 through 30.
